

Emissions reduction targets

To drive our progress towards Net Zero, we have set the following emissions reduction targets:

- Short-Term Target (By 2026): Reduce total emissions by 10% to 203.63 tCO2e.
- Mid-Term Target (By 2029): Reduce total emissions by 20% to 180 tCO2e.
- Long-Term Target (By 2050): Achieve Net Zero emissions.

We will review and adjust these targets annually to ensure they remain realistic and achievable.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives:

• **ISO 14001 Accreditation:** Maintained ISO 14001 accreditation, ensuring effective environmental management practices are in place.



• **Digitalization of Documentation:** Markedly reduced paper waste by adopting digital documentation, including PDF reports, a digital login/logout system, and electronic record-keeping. This transition not only decreases paper consumption but also minimizes emissions from production, printing, and disposal.

Future Carbon Reduction Projects:

- **Fleet Expansion:** Planning on introducing electric vehicles into our fleet by 50% by 2026.
- Renewable Energy: Aim to source 50% of our electricity from renewable sources by 2029.
- Energy Efficiency Upgrades: Target upgrading building insulation and HVAC systems to improve energy efficiency by 15% by 2027.

Carbon Offsetting

In parallel with our reduction efforts, we will invest in carbon offsetting projects to mitigate emissions that cannot be reduced internally. We will support:

- Renewable Energy Projects: To help decarbonize national grids.
- Reforestation Initiatives: To capture and store atmospheric CO2.
- Community-Based Projects: To support local and global sustainable development.

Offsetting Strategy:

- Annual Offsetting Goal: Offset 10% of our total emissions by 2025.
- Preferred Projects: Focus on projects that offer additional social and environmental benefits.

- Transparency: Publish annual updates on emissions and reductions on our website.
